

Administrative Report:

Administrative Report:

- a. Supt. Hafer discussed the following:
 - 1. Mrs. Rogers and students were in attendance to present the draft of the new website which will be hosted through SOCS web site service.
 - 2. Travis Collier discussed automatic sprinkler options. The board asked to price FB field area to further consider.
 - 3. The board reviewed information presented by the architect at the October meeting related to future facility options for the district.
 - 4. The board discussed a possible alternative to property and liability insurance and directed Supt. Hafer to obtain a price quote knowing the district is not likely interested in switching providers.
 - 5. The board was given the Supt. evaluation materials to be discussed at the December 14th meeting along with the Supt's contract.

- If requested on the application, list activities, awards, honors classes, and volunteer or paid jobs. Track them using the Activities Resume at EducationQuest.org.
- If an application requires a letter of recommendation, give the person writing the letter sufficient notice, a specific deadline, and a copy of your Activities Resume.
- After writing an essay, ask an adult (preferably an English teacher) to review the document for spelling, grammar, and sentence structure.
- Follow all directions, and make sure the application is complete and submitted by the deadline or it will be disqualified.
- Never pay for scholarship services! Talk to your school counselor or contact EducationQuest about the many free options available.




