

Art News 2015

On Thursday, September 17, five Sandhills Art Students attended the Halsey Art Workshop held at the Nebraska National Forest. Students were able to participate in two different sessions that were taught by professional artists and art teachers. Kyra Kennedy, Keesha Albrecht. Greg Schukei, Taylor Downing, and Thomas Peterson took time out of their busy week to attend.

Joan Swim, art teacher from Keya Paha, taught pencil drawing. She emphasized doing a sketchbook and using their phones to take pictures of random objects. Students picked out the best photos of their still life arrangement and did several practice drawings during the session. She also had the students go outside to take photos of shadows. They then took the photos and picked out different ones to do timed drawings from.

Linda Lacy is a professional artist from Arthur, Nebraska. She did a clay hand-building project with the students. Each student made a "Crooked House" out of clay using the slab method of hand building. She gave step-by-step directions and by the end of the session students had their own "Crooked House" that were unique with textures and details.

North Platte artist Patsy Smith shared her expertise about painting during her workshop. She had the students do an outer space painting using several acrylic painting techniques.

Cozad artist, Susan Hart, had students do a low relief sculpture using a hot glue gun and aluminum foil. Students started out with an abstract linier design. They applied layers of hot glue over the top of their line drawing to add dimension. The next step was adding aluminum foil over the top along with layers of acrylic paint for color. Susan really emphasized finding design and color ideas from magazine pictures.

We are now in the middle of the fall sports season, and Traumatic Brain Injury (TBI) & the Return to Learn/Play policy has come to the forefront. All sports, not just football, have been at the center of the TBI debate. With that said, thanks to exhaustive research from multiple physicians, there is a Return to Learn/Play policy.

To help keep students safe, all coaches are required to take and pass the National Federation of High Schools (NFHS) *Concussions in Sports* class year. Also, freshmen, juniors, any new student-athlete, and any student with a brain-injury history are required to take the ImPACT test, which is a test used to get a "baseline" for students prior to any brain-injury. The ImPACT test is given, free of charge, thanks to the Nebraska Sports Concussion Network.

If a student were to incur a brain injury, the student must be cleared by a doctor, as well as follow through with the Return to Learn/Play Policy, should the injury be severe enough. Also, even though a doctor may clear a student-athlete, the coach must also "clear" the athlete to play the game. Meaning, if the coach(es) feel the student-athlete is not in a proper frame of mind to participate in the upcoming event, it is ultimately up to the coaches to "clear" him/her for play.

Attached to this note, you will find the policy that both Sandhills & Thedford administration is planning on using when a student has TBI. The policy the administrations will be using comes from multiple sources, including research done by the Brain Injury Institute of Vermont & the Nebraska Sports Concussion Network. Also, you will find an informational page on concussions in sports.

RETURN TO LEARN/PLAY

Step	Progression	Description
1.	HomeTotal Rest	 Can only handle 30 minutes of mental exertion at a time. No computer, texting, video games, or homework. Stay at home. No driving.
2.	HomeLight Mental Activity	 Can handle up to 30 minutes of mental exertion. No prolonged concentration. Stay at home. No driving.
3.	SchoolPart-time Maximum accommodations	 Can handle > 60 minutes of mental exertion. Provide a quiet place for scheduled mental rest. No significant classroom or standardized testing. Modify rather than postpone academics. Provide extra time, extra help, modified assignments.
4.	School—Part-time Moderate accommodations	 Can handle up to 60 minutes of mental exertion. No standardized testing. Modified classroom testing.

NoteProgression is individual, all concussions are different. Students may start at any step as symptoms dictate and remain at that step as long as needed. Return to previous step if symptoms worsen.

CONCUSSION FACT SHEET FOR PARENTS

WHAT IS A CONCUSSION?

A concussion is a type of traumatic brain injury. Concussions are caused by a bump or blow to the head. Even a "ding," "getting your bell rung," or what seems to be a mild bump or blow to the head can be serious.


You can't see a concussion. Signs and symptoms of concussion can show up right after the injury or may not appear or be noticed until days or weeks after the injury. If your child reports any symptoms of concussion, or if you notice the symptoms yourself, seek medical attention right away.

WHAT ARE THE SIGNS AND SYMPTOMS OF CONCUSSION?

If your child has experienced a bump or blow to the head during a game or practice, look for any of the following signs of a concussion:


SYMPTOMS REPORTED BY ATHLETE:

- · Headache or "pressure" in head
- Nausea or vomiting
- · Balance problems or dizziness
- Double or blurry vision
- Sensitivity to light
- Sensitivity to noise
- Feeling sluggish, hazy, foggy, or groggy
- Concentration or memory problems
- Confusion
- Just not "feeling right" or is "feeling down"



SIGNS OBSERVED BY PARENTS/ GUARDIANS:

- · Appears dazed or stunned
- · Is confused about assignment or position
- Forgets an instruction
 - · Is unsure of game, score, or opponent
 - · Moves clumsily
 - · Answers questions slowly
 - Loses consciousness (even briefly)
 - · Shows mood, behavior, or personality changes

DANGER SIGNS

Be alert for symptoms that worsen over time. Your child or teen should be seen in an emergency department right away if s/he has:

- One pupil (the black part in the middle of the eye) larger than the other
- · Drowsiness or cannot be awakened
- A headache that gets worse and does not go away
- · Weakness, numbness, or decreased coordination
- · Repeated vomiting or nausea
- · Slurred speech
- Convulsions or seizures
- Difficulty recognizing people or places
- · Increasing confusion, restlessness, or agitation
- · Unusual behavior
- Loss of consciousness (even a brief loss of consciousness should be taken seriously)

WHAT SHOULD YOU DO IF YOU THINK YOUR CHILD HAS A CONCUSSION?

- 1. SEEK MEDICAL ATTENTION RIGHT AWAY A health care professional will be able to decide how serious the concussion is and when it is safe for your child to return to regular activities, including sports.
- 2. KEEP YOUR CHILD OUT OF PLAY. Concussions take time to heal. Don't let your child return to play the day of the injury and until a health care professional says it's OK. Children who return to play too soon - while the brain is still healing - risk a greater chance of having a second concussion. Repeat or later concussions can be very serious. They can cause permanent brain damage, affecting your child for a lifetime.
- 3. TELL YOUR CHILD'S COACH ABOUT ANY PREVIOUS CONCUSSION. Coaches should know if your child had a previous concussion. Your child's coach may not know about a concussion your child received in another sport or activity unless you tell the coach.

HOW CAN YOU HELP YOUR CHILD PREVENT A CONCUSSION OR OTHER SERIOUS BRAIN INJURY?

- Ensure that they follow their coach's rules for safety and the rules of the sport.
- Encourage them to practice good sportsmanship at all times.
- Make sure they wear the right protective equipment for their activity. Protective equipment should fit properly and be well maintained.
- Wearing a helmet is a must to reduce the risk of a serious brain injury or skull fracture.
 - However, helmets are not designed to prevent concussions. There is no "concussion-proof" helmet. So, even with a helmet, it is important for kids and teens to avoid hits to the head.

HOW CAN I HELP MY CHILD RETURN TO SCHOOL SAFELY AFTER A CONCUSSION?

Children and teens who return to school after a concussion may need to:

- · Take rest breaks as needed
- Spend fewer hours at school
- Be given more time to take tests or complete assignments
- · Receive help with schoolwork
- · Reduce time spent reading, writing, or on the computer

Talk with your child's teachers, school nurse, coach, speech-language pathologist, or counselor about your child's concussion and symptoms. As your child's symptoms decrease, the extra help or support can be removed gradually.

Keep Loup Basin Beautiful Project Coordinator, Mary Hughes implemented a new program in our 13-county region during the 2014-15 school year. Hughes contacted 37 area schools asking them to participate in the Crayola Marker Recycling Program. This amazing new program is devised to turn used markers into energy. This program takes any kind and brand of marker.

This past school year, area students and teachers collected used markers that were ready to be discarded and collected them until the end of the school year. Hughes then traveled to all the schools to pick up the used markers.

Hughes commented "I was very pleased with how quickly all the schools embraced the marker recycling program. And I have had 4 more schools ask to be added to our list of schools participating for the 2015-16 school year! I hope to keep adding any schools in our 13-county region that would like to participate."

"I hope to see a significant increase each year in the number of pounds of markers collected in our 13-county region and keep these markers out of our landfills."

"So far this year, I have collected over 84 lbs of markers to be sent in to be recycled."

It's time to get vaccinated for Influenza if you haven't already! Influenza (flu) is a contagious disease that is spread mainly by sneezing, coughing and close contact. Anyone can get influenza. Symptoms can include: cough, headache, runny or stuffy nose, fever/chills, fatigue, muscle aches, sore throat. Influenza is more dangerous in adults over age 65, young children, pregnant women and people with certain health conditions or weakened immune system. A dose of flu vaccine is recommended every flu season for ages 6 months on up. It takes about 2 weeks to develop protection from the flu shot. Good handwashing is the number one way to prevent the spread of germs!

Thursday, November 19 is designated as Great American Smokeout 2015. This began in 1970 in Massachusetts when a man asked people to give up smoking for one day and donate the money saved to the local high school scholarship fund. Smoking is responsible for 1 in 3 cancer related deaths. Life expectancy for smokers is 10 years less than for non-smokers. If you are a smoker call 1-800-QUIT-NOW for support in quitting. Dear Parents,

The *No Child Left Behind Act of 2001* (NCLB) requires that all states create high academic standards for the core areas of reading, writing and math. The goal of NCLB is for every student to meet or exceed these standards by the school year 2014. The measure of annual progress toward these standards is called Adequate Yearly Progress (AYP). AYP is based primarily on the results of the Nebraska state assessments given to students in grades 3 through 8 and grade 11. Schools must meet the state's academic proficiency benchmarks, as well as other indicators such as test participation and attendance/dropout rate, to make AYP.

In addition to measuring each school, NCLB also requires the Nebraska Department of Education (NDE) to annually review the progress of each school *district*. Based on Nebraska State testing results, Sandhills Public Schools was identified by the NDE as a district in need of improvement for the 2015-16 school year. A district is identified for improvement if it meets this criterion:

Does not make AYP in all grade spans within the district-elementary (grades 3-5), middle school (grades 6-8) and high school (grades 9-12)--for two consecutive years in either content area of math or reading, considering all eligible student subgroups. Overall, Sandhills students have scored well on assessments. But, due to the 100% proficient requirement of the Federal Accountability under NCLB, the district falls short even though 80% & 87% of students in reading and 80% & 77% of students in math proved proficient in 2013-14 and 2014-15 respectively. In addition, Sandhills did have sub groups who met 100% proficiency. We are proud of our students and teachers efforts. To be removed from the district improvement status, the district must meet the grade span achievement standards for two consecutive years. If you would like to compare achievement scores in the district to others across the state, you may access the information on the Nebraska Department of Education (NDE) *State of the Schools Report* at http://reportcard.education.ne.gov.

As a Title 1 district identified in need of improvement, Sandhills Public Schools is required to communicate the district improvement plan strategies specifically addressing the teaching and learning needs of low-achieving students. The goals and strategies identified in the plan intentionally focus on optimizing instruction for all learners using researched based practices with on-going professional learning for staff. Sandhills Public Schools is dedicated to providing all students with a quality education that prepares them to be career and college ready. Sandhills Elementary is also identified as a school in Need of Improvement. According to 2014-2015 state student assessment (NeSA) results Sandhills Elementary is in Year 1 of Title I in Need of Improvement for the 2015-2016 schoolyear under the federal No Child Left Behind (NCLB) law. We are required to meet reading and math goals of 100% proficient in multiple subgroups in order to meet Adequate Yearly Progress (AYP). If one of these subgroup goals is not met, the school is labeled as not meeting AYP. In 2014-2015, we did not meet AYP in 2 subgroups in Reading and 2 subgroups in Math.

The identification of being in Year 1 of Title I school improvement for the elementary school requires Sandhills to offer Public School Choice. However, because Sandhills is the only elementary school in our district there is no transfer option available to our students.

You are encouraged to contact the district office for further information on any of these requirements and to find out how you can become involved in school improvement efforts. An important part of this effort involves parental involvement and support. Participating in parent/teacher conferences, attending parent/family nights and providing "at home" strategies to support reading and math learning are also key to supporting the home/school partnership. We will continue to communicate with you throughout the year regarding the school improvement efforts underway and hope you will join us in supporting our students and teachers as we work toward reaching our goals for next year. Also, please read the accompanying letter by NDE Commissioner Dr. Matt Blomstedt who does an excellent job of pointing out the issues with this unreasonable rating imposed on the Federal Level which is tied to district Title I funding. We appreciate NDE's and Dr. Blomstedt's support recognizing our district is doing good work and is committed to serving our district's children.

The Elementary and Secondary Education Act (ESEA), was passed in 1965 during the Lyndon B. Johnson administration as part of the War on Poverty. The act emphasized equal access to education, established high standards and accountability, and authorized federally funded education programs administered by individual states. Congress amended ESEA in 2002 and reauthorized it as the No Child Left Behind (NCLB) Act. The law was scheduled to be reauthorized in 2007; to date Congress has not taken the necessary steps to update this law. In recent months, both the Senate and Congress have passed their versions of what they believe should be included in reauthorization of the ESEA. The next step is for members of both the Senate and Congress to form a Conference Committee to come up with a single plan for reauthorization. It is anyone's guess whether ESEA will actually be reauthorized by the end of this year.

When states and districts agree to accept federal funds, there are strings attached. Attached to NCLB Title I funding is the stipulation to have statewide assessments and Adequate Yearly Progress (AYP) decisions for every public school in the state. Under NCLB, the proficiency goal for school year 2014-15 for reading and mathematics assessments was set at 100%. According to the NCLB rules, every student - regardless of disabilities, English language proficiency, or other life-impacting circumstances -- must be proficient in reading and math as measured by state assessments. Because of this unrealistic goal, a number of Nebraska schools will be unfairly labeled as *Not Met* or *In Need of Improvement*.

The Nebraska Department of Education does not agree with the current federal policy. I do not believe that all of our schools are low performing. In fact, the U.S. Department of Education (USDE) has granted waivers from the unrealistic expectations of NCLB. Common sense tells us that one child in one grade in one subject area scoring just below a "proficiency cut score" should not brand an entire school community as failing. Yet that is exactly what has happened under NCLB. As a result of this faulty logic, some schools or districts in Nebraska have not met the NCLB requirement for the 2014-15 school year.

In April, 2015, Nebraska submitted a request to the USDE, for waivers from several of the NCLB requirements. NDE has had follow-up conversations with USDE staff, but to date no formal response has been received. This means that for the 2014-15 school year, all NCLB requirements must be followed. NDE was hopeful that some of the requirements, such as the 100% proficiency goals for

reading and math could be waived, but our real hope is that reauthorization takes place very soon, so that all states will be relieved of the unrealistic and harsh consequences of the current law.

Nebraska educators are committed to each and every young person reaching his or her full potential and we are proud of the significant academic progress of our students. While not all students have reached proficiency, the use of targeted resources to assist struggling students and schools has had an impact which is seen in performance data not taken into account by NCLB. Our students, staff members, and schools are not failures. By many measures, they are demonstrating unprecedented levels of achievement. We continue to strive for improvement and excellence in our public schools.

We are committed to continuous improvement. Gains in student achievement are due to the collaborative efforts of teachers, staff, parents, and community members through high-quality instruction, effective leadership, and partnerships. We know that tests are an important part of teaching and learning, but we also understand that basing a student's achievement on a single assessment does not capture everything that is important for our children's learning journey.

As a state, our biggest challenge is finding better ways to engage and support the learning of every student, every day. Nebraska continues to develop and refine a system for Accountability for a Quality Education System, Today and Tomorrow (AQuESTT). The State Board of Education believes that Nebraska citizens—through the Constitution, the Nebraska Legislature, the State Board of Education, the Commissioner of Education, and other policy makers—are responsible for the total design of this education system. While acknowledging that this education system will be influenced by others, (federal government, other state leaders, and local policy makers) this system will be dependent on and driven by local boards of education, administrators, teachers, parents, communities, and students. This belief requires that we listen well, communicate better, and engage leaders and stakeholders across the state. The goal is to build a quality accountability system that is meaningful to Nebraska. The AQUESTT system focusses on six tenets which are part of two broader principles. We believe that each tenet is equally important.

STUDENT SUCCESS AND ACCESS Positive Partnerships, Relationships, & Student Success Transitions Educational Opportunities & Access TEACHING AND LEARNING College and Career Ready Assessment Educator Effectiveness

As a parent or caregiver, we encourage you to look at your own child's individual growth and learning, along with evidence your school provides related to your child's progress instead of an outdated mislabeling requirement imposed by the federal government. We also encourage you to work with your local educators to ensure that every child is challenged and supported, learning, and thriving. Schools prosper when parents and caregivers are involved as the first teachers of their children.
